Please note the following Over Subscription Criteria:

If, on the date for the deadline for the submission of registration forms, the applications for admission exceed the number of places available, the following criteria will be applied. If there is a need to apply further criteria, places will be allocated based on the date and/or time on a particular date the registration was received within the above criterion. After the admission of pupils with an Education, Health and Care Plan, priority for admission will be given to those children who meet the criteria set out below, in priority order:

1. Looked after children and children who were previously looked after but immediately after being looked after became subject to adoption, a child arrangements order, or special guardianship order, including children who appear (to the trustees) to have been in state care outside of England and ceased to be in state care as a result of being adopted.

2. Children living within the catchment area and who are eligible for pupil premium. Evidence of eligibility will need to be submitted with the application. See notes below on eligibility.

3. Children living within the catchment area and who are a sibling of pupils attending the school at the point of admission.

4. Other children living within the catchment area.

5. Children who are eligible for pupil premium but do not live within the catchment area.

6. Siblings of pupils attending the school at the point of admission, but who do not live within the catchment area.

7. Other children.
